SUBJECT: FY 2023-24 BUDGET STUDY SESSION

**RECOMMENDATION:** For information only, no action.

**BACKGROUND:** The Council needs to approve a budget for FY 2023-24 prior to the end of the current fiscal year. Under city procedures, the city manager prepares a proposed budget which is then presented to the Council for discussion and possible approval. This year the Council will be holding two study sessions on the budget, the first at this meeting and the second on June 5. These study sessions are designed to allow the Council to take an in-depth look at the budgeting process and the proposed budget without having to make a final decision. The action to adopt the budget for the next fiscal year will be taken following a public hearing at the June 20 regular meeting.

**DISCUSSION:** The first part of the session will be a staff presentation on the basics of municipal budgeting and finance, with a more specific look at some issues particular to the city financial situation and their impact on budgeting going forward. The second part of the session will be a presentation by Mark Hildebrand on a more detailed look at WW issues and budgeting impacts. The final part of the session will be for public comments to Council. Staff will present the proposed FY 2023-24 budget to Council at the June 5 Study Session.
